Privacy Policy

We (hereinafter also referred to as the "Company") – Limited Liability Company "AntUnity" (UNP 193373671, 220038, Republic of Belarus, Minsk, Kozlova St., 24/16, office 3) – collect certain personal data when you use our website Antunity.tech ("Site").

This privacy policy ("Policy") explains what personal data we collect, why we need it, and how we process it.

#### 1. Cookies

Cookies are small text fragments that are stored by the browser on your computer, mobile phone, or other device when you use the Site. For the purposes of this Policy, the term cookies also includes pixel tags, web beacons, and other similar files and technologies that perform similar functions.

Cookies can be "session" (stored while you are on the Site and deleted when you close the browser window) or "persistent" (stored as a file on your device for a specified period or until manually deleted).

Depending on their purpose, cookies may collect the following data: device type, unique browser ID, IP address, unique cookie ID, browser type, language, geographic region (country, region, time zone), operating system, system settings, interaction with other sites, and more.

The Site uses the following types of cookies:

Strictly Necessary Cookies. Required for proper Site functionality and used by default. Do not collect personal data.

Statistical Cookies. Help us understand how users interact with the Site. Activated after you give consent via a pop-up window. All data collected via statistical cookies is anonymized (i.e., it does not directly identify you).

Marketing Cookies. Store information about user behavior based on continuous tracking of repeated actions during navigation. These cookies allow personalization of advertisements and other materials related to the company. Activated only after your consent via a pop-up.

Occasionally, "unclassified" cookies may appear on the Site. These are files not yet recognized by the cookie repository. We continuously update the repository with new cookies, classifications, and purpose descriptions, though this may take time. "Unclassified" cookies will later be categorized and used accordingly.

### 2. Disabling Cookies

Detailed instructions for disabling cookies can be found for the following browsers: Chrome, Explorer, Microsoft Edge, Firefox, Safari, Opera.

If you configure your browser to block strictly necessary cookies, some sections or features of the Site may malfunction or not work at all.

### 3. Third-Party Access to Your Personal Data

When visiting the Site, your personal data may be collected and processed by third parties – owners of the services listed below:

Google Analytics – a web analytics service that automatically tracks site traffic and analyzes user behavior. Owner: Google LLC, 1600 Amphitheatre Parkway, Mountain View, CA, 94043, USA.

Yandex.Metrica – a web analytics service that automatically tracks site traffic and analyzes user behavior. Owner: LLC "YANDEX", 119021, Moscow, Leo Tolstoy St., 16.

Facebook Ads Manager – a tool for creating, measuring, and optimizing advertising, including building custom audiences via Facebook Pixel. Owner: Meta Platforms, Inc., 1601 Willow Road, Menlo Park, CA, 94025, USA.

- 4. Your Rights and Our Responsibilities

Your Right | Our Obligation

- Request information about the processing of your personal data including: our name and address, confirmation of processing, your data and source, legal basis and purpose, consent duration, authorized data processor details, and other legal information. No justification needed. Free of charge.
- Within 5 working days: provide information or deny with justification.

- Request a list of third parties who received your data (once per calendar year, free).
- Within 15 days: provide the list or deny with justification.
- Withdraw consent at any time without explanation.
- Within 15 days: stop processing and delete your data (or block it if deletion is technically impossible), and notify you.
- Request correction of incomplete, outdated, or inaccurate personal data.
- Within 15 days: correct the data and notify you or deny with justification.
- Request termination of processing and deletion of your data (free of charge).
- Within 15 days: delete and notify you, or block it, or deny if there are legal grounds for continued processing.
- Appeal our actions or inaction violating your rights by filing a complaint with the National Center for Personal Data Protection.
- 5. How to Exercise Your Rights

To withdraw consent, send an email to development@antunity.tech stating your request and data allowing us to identify you among other users.

Your request must include:

- Full name;
- Address of residence;
- Date of birth:
- Description of request;
- Personal or digital signature.

To update your data, attach documents (or certified copies) confirming the need for changes.
